Our Neighbors Helping Neighbors (NHN) Program Matches volunteers with older adults
and adults with disabilities to enable them to age with dignity in their own homes
for as long as possible. We accomplish this by working in cooperation with local
congregations and community organizations throughout the greater Mercer County area.
All of our services are non-medical and provided free of charge. In 2025, 246
volunteers provided over 13,500 hours of time, providing care giving services, with
an estimated inkind value of \$499,465

Our AmeriCorps Seniors Retired and Senior Volunteer Program (RSVP) carefully recruits
and trains volunteers 55+. Our Volunteers are then trained to lead our wellness
program or matched with care receivers. Our program enables our volunteers to gain
the benefits of volunteering: Pride in community, social interaction, and a sense of
meaning that in turn supports their own healthy aging. In 2025, we had 164 qualified
RSVP volunteers supporting our NHN and PHB programs.

Our project Healthy Bones (PHB) program is a free osteoporosis prevention exercise
and education program for seniors. It is designed to improve strength, balance and
flexibility. PHB participants learn about the importance of exercise, nutrition,
safety, drug therapy & lifestyle factors that relate to osteoporosis. Another
important benefit of the program is the opportunity for social engagement of its
participants. In 2025, the program had 216 participants at various locations
throughout the greater Mercer County Area.
